General Rules:

HOLLY SHELTER SHOOTING RANGE

GENERAL RULES

This is a **COLD RANGE!** All firearms must be unloaded and cased unless safely on the firing line

Use of the range is allowed only during hours of operation posted on site or during authorized events. Range use during other times is considered trespassing

Shooters, under the age of 17, who participate in either firearms or archery activities, must be accompanied by an adult. The adult must be at least 21 years old, & will accept full responsibility of the minor

All Federal, State and local firearm laws must be obeyed

No Steel Core, XM193, Green Tip, Tracer or Incendiary Ammunition allowed on any range

No 50 BMG or Larger Caliper weapons allowed, .338 Lapua included

Class 3 weapons and rapid fire of weapons is prohibited

No one under the influence or in possession of alcohol or drugs is allowed at the range

Smoking, including e-cigarettes, is allowed only in the parking lot

Running and/or horseplay is prohibited on the range

Pets are not allowed at the range

Closed-toed shoes are required for all shooters & visitors

For personal protection & safety, shooters are not allowed to wear sleeveless shirts

Please do not hike, explore, or play on the berms

All range users (shooters & visitors) are personally responsible for range safety. If you have questions concerning range safety rules, please consult a Range Safety Officer.

If you observe any unsafe conditions, report them immediately to staff

Any displaying unsafe actions will be asked to correct their behavior. Continued violations will result in removal from the range

General Firearms Rules:

HOLLY SHELTER SHOOTING RANGE

GENERAL FIREARMS RULES

DO NOT HANDLE FIREARMS WHEN SOMEONE IS DOWN RANGE

This is a **COLD RANGE!** All firearms must be unloaded and cased unless safely on the firing line

All Federal, State and local firearm laws must be obeyed

Listen to the Range Safety Officer and follow range commands

Safety glasses and hearing protection must be **ALWAYS** worn by shooters and spectators. (Ear protection of the **EARMUFF** type is recommended by Federal safety regulations)

Food, beverages and smoking are prohibited on the firing line

ALWAYS keep the firearm pointed in a safe direction

ALWAYS keep your finger off the trigger until ready to shoot

ALWAYS know your target and what is beyond

Shoot only at the target in front of you, cross lane firing is prohibited

Use only correct ammunition for your firearm

All persons, belongings, targets, Ammunition and firearms are to remain forward of the **BLUE LINE** while on the firing line. This is to permit a fast, uninterrupted path for the Range Safety Officer should an emergency arise

There is to be **NO** firing a firearm from the hip. This includes pistol grip shotguns

There is to be **NO** hand-to-hand transfers of firearms on the firing line. If you want to pass a firearm to another shooter, place the firearm on the firing line bench and step back. Then the other shooter may step forward and pick up the firearm

Do not remove a jammed or malfunctioning firearm from the firing line without the Range Safety Officer's approval. If you have a jam or malfunction and can safely correct the issue while keeping the firearm pointed downrange, the do so. Otherwise ask a Range Safety Officer for assistance.

No Steel Core, XM193, Green Tip, Tracer or Incendiary Ammunition allowed on any range

No 50 BMG or Larger Caliper weapons allowed, .338 Lapua included

Range Safety Officers have the right to inspect any firearms or ammunition at any time

If the command "**CEASE FIRE**" is given; stop shooting immediately, remove your finger from the trigger, remove magazine, clear firearm, place firearm on the bench. Step back behind the **BLUE LINE** and wait for further instructions from the Range Safety Officer

When going down range to put up or remove targets, stay on the walkways to and from targets

All range users (shooters and visitors) are personally responsible for range safety.

If you observe any unsafe conditions, report them immediately to staff

Anyone displaying unsafe actions on the range will be asked to correct their behavior. Continual safety violations will result in removal from the range

General Archery Rules – Practice Range Rules – 3D Range Rules

HOLLY SHELTER SHOOTING RANGE

GENERAL ARCHERY RULES

Sky drawing is prohibited

Broadheads are NOT allowed on the range

No handling of bows while others are down range

Firearms are prohibited on the archery range

No not nock an arrow until ready to shoot

No shooting at unauthorized targets (cans, boxes, etc.)

If you observe any unsafe conditions, report them to staff immediately

All range users are personally responsible for range safety and safe shooting practices. If you have questions concerning range safety or range rules, please consult a Range Safety Officer

PRACTICE RANGE RULES

This range is primarily for the use of archery sight in & practice

Crossbows are allowed on this range ONLY

Shooting is to be directed at targets only

Do NOT nock arrows or cock crossbows until EVERYONE is behind the shooting line

Keep arrows pointed down range in the direction of the target

Wait until all archers have agreed that the line is clear before retrieving arrows

Destroying targets to retrieve arrows is prohibited

3D RANGE RULES

Crossbows are prohibited on the 3D Target Range

Shoot from designated stakes ONLY

Allow faster groups to shoot through

This is a “pull with consideration” course

No member of the shooting group is allowed to step forward until all members have completed shooting

Please notify range staff if any target is missing or not operatable

NO REFUNDS

Shotgun Range Rules:

HOLLY SHELTER SHOOTING RANGE SHOTGUN RANGE RULES

CHECK-IN: All visitors **MUST** check in with an RSO before beginning the 5-Trap.

CASED FIREARMS: All firearms must be cased when approaching the range. Once checked in, patrons can uncase their shotguns & proceed as normal.

LOADED FIREARMS: Loaded firearms are only allowed on trap/skeet shooting positions and 5 stand tower shooting positions.

SHOT SIZE: Shot size shall **be no larger than #7 steel shot**. RSO shall check shotgun ammunition prior to use on the 5 Stand Range.

SHELL TYPE: **STEEL SHOT ONLY** at Holly Shelter Shooting Range

MUZZLE DIRECTION: All firearms must be pointed downrange when loaded and ready to shoot. In the case of a malfunction, the muzzle shall remain downrange.

LOADING: A maximum of two rounds may be loaded into a shotgun at any time.

AUTOLOADERS AND PUMP ACTION: Autoloaders and pump action shotguns shall have the bolt locked open when not actively shooting from 5 stand shooting positions.

SINGLE- AND DOUBLE-BARREL ACTION: Single- or double-barrel shotguns shall have a broken action when not actively shooting from 5 stand shooting positions.

ROUNDS: One round of 5 Stand shall include around 25 clays.
